  - 1. **2<sup>nd</sup> Reading – Ordinance/Amend Code 22-4 – Giving false name, address, or birthdate to law enforcement officer** – A motion was given by Bagwell to approve with a second from Wiley. Motion Carried.

6. **Agreement – K9 “Klaus”** - McBurnett reviewed the Canine Agreement with K9 Klaus and Officer Allen who will be his handler. A motion was given by Bagwell to approve with a second from Wiley. Motion Carried.
7. **Resolution – 2019 Election Results** - 2019 Election results was reviewed with Al Pallone as Mayor, Vince Wiley as Council Member and Charles Lowry as Council Member. The “Brunch Bill” was also passed. A motion was given by Brush to approve with a second from Bagwell. Motion Carried.
8. **Discussion – Restricted Road Ways** - A discussion on restricted road ways within the City of Emerson was held. Mark O'Brian, President and CEO of Lake Point Sports spoke in support of making Lake Point Parkway North to be a truck restricted roadway. O'Brian stated the reduction of vehicular traffic would allow for more pedestrian walkways as the plan was originally intended in this area. McBurnett reviewed the restricted roadways as recommended by the Planning & Zoning Commission to also include; Fourth Street, Sixth Street, Seventh Street, Gaston Westbrook Avenue, Keeling Mountain Road, Old Alabama Road. McBurnett stated he would review these roads and speak with legal to work on a new ordinance for this issue.


Mayor Pallone announced the Christmas Program will be held on December 10<sup>th</sup> at 6:30 pm and invited everyone to attend.
